

**TRINITY ACTIVITIES PERMISSION, ASSUMPTION OF RISK, WAIVER OF LIABILITY, AND MEDIA RELEASE**

In consideration of the benefits received from participating in meetings and activities (which may include travel) in person (“Trinity Activities”) sponsored by Trinity Church Wall Street including its clergy, wardens, vestry, officers, employees, members, lay leaders, volunteers, independent contractors, agents, and all other persons or entities associated with it (“Trinity”), I on my own behalf and on behalf of any minor listed below who is participating in Trinity Activities and for whom I have the capacity to contract as parent or legal guardian (each, a “Minor”), acknowledge and agree as follows:

**COVID-19 Warning:** The World Health Organization has declared the novel coronavirus COVID-19 to be a worldwide pandemic. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and health agencies recommend vaccinations, wearing masks, social distancing, and have, in many locations, limited the congregation of groups of people. Trinity has put in place preventative measures to reduce the spread of COVID-19; however, Trinity **cannot guarantee** that I and/or Minor will not be exposed to or become infected with COVID-19. **My and/or Minor’s travel to and participation in Trinity Activities could increase my and/or Minor’s risk of contracting COVID-19.**

**Additional Risks:** Participating in Trinity Activities may have other inherent risks, hazards and dangers. Trinity Activities taking place outdoors or requiring physical exertion indoors may result in accidents, injuries, property damage, illness, disability or death. Persons leading Trinity Activities may be unpaid volunteers and not professional guides or leaders. I agree that I and/or Minor are participating voluntarily with knowledge of the risks, and I take responsibility for my and/or Minor having appropriate skills, equipment, supplies and physical conditioning to engage in the specific Trinity Activities.

**Assumption of Risks:** By travelling to and participating in in-person at Trinity Activities, I on behalf of myself and if applicable my Minor voluntarily assume the risk and agree to accept sole responsibility for any injury, illness, personal or property damage, loss, claim, liability, or expense of any kind, including those resulting from disability or death, that I or my Minor experience or incur in connection with my and/or Minor’s experience at Trinity Activities, including but not limited to those that may result from exposure to or infection with COVID-19 (“Claims”). I understand that the risk of me or Minor, if applicable, becoming exposed to or infected by COVID-19 at Trinity Activities may result from the actions, omissions, or negligence of others, including but not limited to Trinity employees and other guests. **On my own behalf, I, and if applicable, on behalf Minor, hereby release, covenant not to sue, discharge, indemnify, and hold harmless Trinity (as defined in this waiver) from the Claims, including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating thereto.**

By participating in and/or permitting Minor (if applicable) to participate in-person at Trinity Activities, I certify that I have read and fully understand this waiver and agree that the release will be binding on me, my heirs, family, estate, representatives, and assigns, as well as the heirs, family, estate, representatives, and assigns of any of Minor (if applicable). This release shall be interpreted and controlled according to the laws of the State of New York.

This form is my global permission for Minor to participate in Trinity Activities, and my permission will be effective for the period from the date below through the end of the applicable Trinity Activity unless I withdraw my permission in writing before that time. **I HAVE READ AND UNDERSTAND THIS DOCUMENT AND, ON MY OWN BEHALF AND IF APPLICABLE, ON BEHALF OF MY MINOR, I VOLUNTARILY AGREE TO ITS TERMS.**
